

Tysons Trek & Treat Game Rules and Regulations

These rules help ensure that the game is enjoyable, fair, and safe for all participants. By registering for the game, participants agree to abide by these rules and regulations.

- 1. A valid email address is required for registration. The email address will be used to facilitate communication about the game or prizes. The email address will serve as a unique identifier for all your submissions.
- 2. Participation in the game requires submission of a photograph of the participant at a specific location and/or a screenshot of a map clearly showing your claimed activity. Participants who prefer not to be in the photo may opt to use a mascot (i.e., a toy, stuffed animal, or totem) instead.
- 3. All Walk, Bike, or Roll trips by a participant must start at the same chosen location: home, work, or hotel. The goal of the game is to identify the number of destinations that are within reach from that starting point and explore the range of trips that can be completed using active transportation.
- 4. The game is intended to occur within the Tysons urban boundary. Exceptions may be requested by providing a comment in the game form or contacting the TCA Transportation Team at transportation@tysonsva.org.
- 5. Participants consent to the use of their photos, screenshots, and feedback submitted during the game for TCA promotional purposes.
- 6. No purchase is necessary to participate in the game, enter the raffle, or win prizes.
- 7. There will be six (6) weekly raffle drawings. Drawings will be held on October 10, 14, 21 and 28, and November 4 and 11, 2024. All entries received before midnight each Sunday will be entered into the drawing held on the following Monday. Winners will be informed via email and must respond with their preference between a gift card to REI or Nordine Salon & Day Spa.
- 8. The game ends on November 10, 2024 at the stroke of midnight! All entries for the Basic and Advanced Challenges must be received before the game ends.
- 9. The organizers reserve the right to modify the rules, tasks, or schedule of the game if necessary. Any changes or cancellations will be



- communicated to participants via the Explore Tysons weekly email and posted on the game webpage.
- 10. Participants are required to exhibit good sportsmanship and respect towards other participants and game organizers.
- 11. Participants must follow all local laws and regulations while participating in the game. Please respect public and private property.
- 12. Participants should be mindful of their own safety as well as those around them. Participants should use appropriate safety equipment (e.g., helmets, reflective gear) while playing the game.
- 13. Participants agree to hold the organizers harmless from any liability or claims arising out of participation in the game. The organizers are not responsible for any injuries or accidents that occur during the game.
- 14. Personal information collected during registration or participation will be used solely for the purpose of communication and updates about the game and the Tysons Community Alliance (TCA). Participants will have the opportunity to opt out of receiving TCA information and updates. This information will not be shared with any third party.
- 15. Any disputes or issues regarding the game will be resolved by the organizers, whose decisions are final and binding.
